The once-a-month Angel Food is available in a quantity that fits into a medium-sized box. **The cost is \$30 for approximately \$60 worth of fresh, frozen and boxed or canned food items. You can order as many monthly boxes as you can use. Each regular box is \$30.**

In addition to the regular monthly food box, there are special, bonus boxes containing meats, produce and/or holiday meal options. Bonus boxes are an additional cost and prices vary.

Monday, June 14, is the last day to order in person for June. The order office closes at 3:00 PM. The office is closed daily from 11:30 AM—Noon for lunch.

ON-LINE orders can be placed until Sunday, June 20. There is a \$2 processing fee for on-line orders. Be sure you select SCCS as your host site when ordering on-line.
